There were some last minute changes in the date of issue for the lenticular stamps. A prepaid post card was sent to all individuals with a standing order for Irish stamps. The card read:

Dear Customer,

I wish to notify you that the issue date for the Ryder Cup Lenticular stamps has been deferred from Thursday, 14th September until the following Tuesday, 19th September 2006. The decision to defer the issue date is because of uncertainty about our ability to supply all Post Offices by the original issue date. You may have seen these stamps being promoted on last Friday's Late Late Show, and strong demand is expected.

I hope that this deferral does not inconvenience you.

Special Cancellations were available for each day of the Ryder Cup Matches. These cancellations were the same as the ones used for the First Day of Issue except for a wording change to reflect the Ryder Cup instead of La Chead Eisiuna which translates to First Day of Issue and the location was changed from Baile Aatha Cliath (Dublin) to Teach Straffan, location of the Matches.

The cancellation available during the Matches is shown here.

Reportedly thirty two covers were carried on a special Air Lingus flight from Dublin to London on September 25th, 2006 with the European Team members aboard. A source for these covers has not yet been identified.

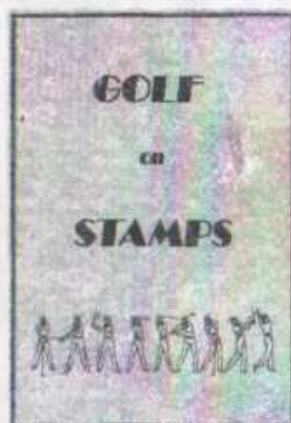
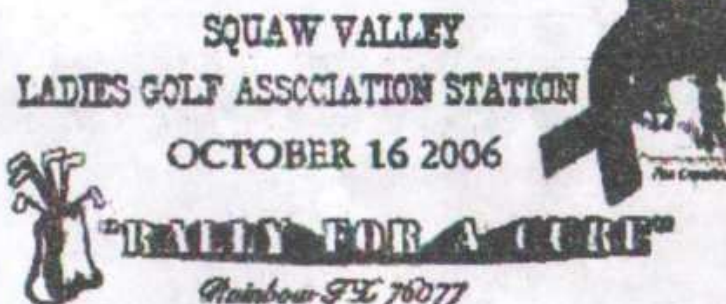

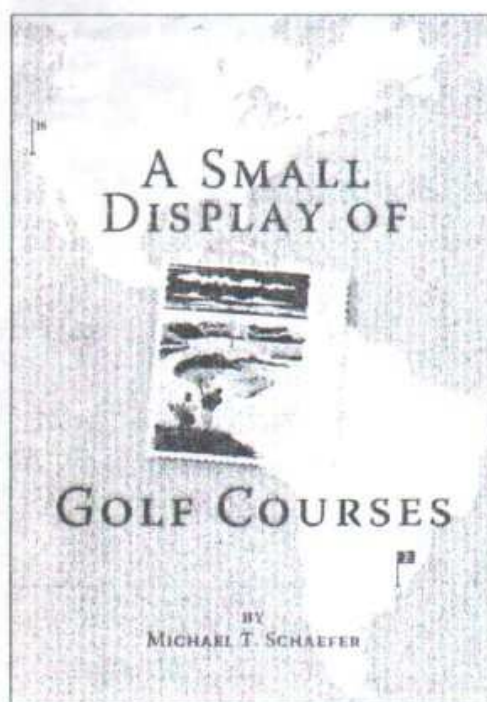
